

2024 Winter Storm Emergency - Weekly Temporary Lodging Summary -

Housing Authority of the County of San Diego (Excluding Unincorporated), Data as of Monday, April 22, 2024, Updated[^]

A major flooding event occurred on January 22, 2024 in San Diego County. Through a region-wide damage self-report survey, 211, the County and City Local Assistance Centers, Emergency Temporary Intake Process, and calls, there were about **330 initial reports of property damage or other type of storm impact** to residential and commercial locations in the Housing Authority of the County of San Diego (HACSD), excluding Unincorporated areas. Of those, **10 residential locations were classified as major damage, 110 were renters, and 208 were owners**. This report summarizes the current status of **56 households or cases** managed by Equus (County contractor) and the County in the HACSD, excluding the Unincorporated areas. The HACSD is the authority for 13 municipalities in the county and the unincorporated areas.

Summary

- There are 21 households in seven municipalities covered by HACSD (excluding unincorporated) placed in emergency temporary lodging as of April 22.
- All currently placed households applied for FEMA assistance as of Monday, April 22.
- As of April 22, about \$2.3 million was awarded by FEMA in these areas, of which about \$36,200 went to six placed households.

*Left the program due to own choice or no longer eligible. Rarely, for non-violent offenses, one warning is given for the first Code of Conduct violation and households are asked to leave if there is a second violation.

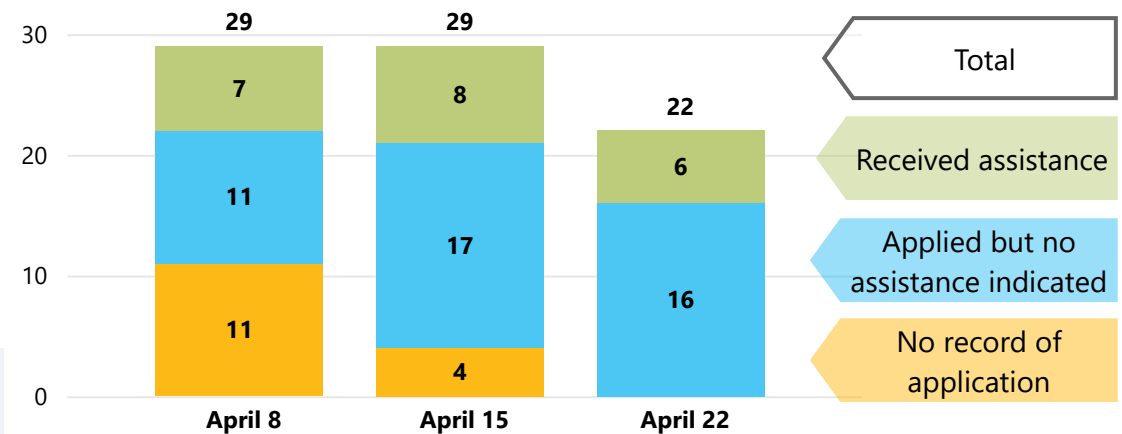

FEMA Assistance Status of Households Placed in Hotels



- Received assistance = FEMA assistance includes rental assistance, home repair, etc.
- Applied but no assistance indicated = may be a temporary status, such as not yet processed by FEMA or lack of documentation, or the household may not be eligible.
- No record of application = may be due to inability to match the records or households may not have applied due to miscommunication, hesitancy to contact government, etc.
